After being restored by Henry VIII to the earldom of Salisbury in 1512, her deep Catholic convictions were increasingly out of favour with Henry and she was executed on a charge of treason in 1541. In 1886, Margaret Pole was among sixty-three martyrs beatified by Pope Leo XIII for not hesitating 'to lay down their lives by the shedding of their blood' for the dignity of the Holy See. Edmund Tudor, Earl of Richmond, takes his child bride into Wales where she discovers a land of strife and strangers. At Caldicot Castle and Lamphey Palace Margaret must put aside childhood, acquire the dignity of a Countess and, despite her tender years, produce Richmond with a son and heir. While Edmund battles to restore the king's peace, Margaret quietly supports his quest; but it is a quest fraught with danger. As the friction between York and Lancaster intensifies 14-year-old Margaret, now widowed, turns for protection to her brother-in-law, Jasper Tudor. At his stronghold in Pembroke, two months after her husband's death, Margaret gives birth to a son whom she names Henry, after her cousin the king. Margaret is small of stature but her tiny frame conceals a fierce and loyal heart and a determination that will not falter until her son's destiny as the king of England is secured. The Beaufort Bride traces Margaret's early years from her nursery days at Bletsoe Castle to the birth of her only son in 1457 at Pembroke Castle. Her story continues in Book Two: The Beaufort Woman.
