Water resource systems research provides a basis for rational water management in large basins. The design and operation of water resource systems are both the most complicated and the most important tasks of water management. This book deals with the basic issues involved in the application of systems sciences to water management. A survey of the systems sciences (the general systems theory, cybernetics, systems engineering, operations research and systems analysis) is presented, as well as the methods for water resource systems analysis and for water resource systems analysis and for their evaluation. The mathematical methods used in systems theory have been given detailed treatment. Linear and dynamic programming have been used as models of optimal

programming. Since many practical tasks require the simulation models of water resource systems, apart from their principles and a detailed description, the simulation language for computing programming has been included. To ensure its members are well-prepared, the profession should institute residency training for nurses, increase the percentage of nurses who attain a bachelor's degree to 80 percent by 2020, and double the number who pursue doctorates. Furthermore, regulatory and institutional obstacles -- including limits on nurses'

scope of practice -- should be removed so that the health system can reap the full benefit of nurses' training, skills, and knowledge in patient care. In this book, the Institute of Medicine makes recommendations for an action-oriented blueprint for the future of nursing.
